## Plat Book Update

Kelly is receiving phone calls from plat book publishers inquiring if we are going to do a new book. The board asked for some cost and details of their publishing cost for a new book. Kelly will get this information and share that at the next board meeting. In the meantime the board decided to sell the remaining 2013 Plat Books for \$10 each. Kelly will update the website and place on our Facebook page.
