### **Snow Fence Replacement**

At the March meeting the board asked Kelly to check on prices for replacing the plastic snow fencing used at the county fair around the outside of the Antique Tractor display. Kelly was able to get a price from Grainger of \$43.95 per 4'x50' roll. The staff will get a measurement of the booth space on the fairgrounds and then place an order. Dan Megel made a motion to go ahead with this purchase for the amount necessary based on the measurements, with a second from Jerry St. John. All were in favor.

Dan Megel asked if we had any contact from anyone interested in the Plot Master. Bob and Kelly said that we had a couple of people make contact about it but no takers as of yet.

#### **New Business**

#### **Tent Replacement**

Kelly advised the board that after last year's county fair that it was mentioned we needed to replace the tarp for our Antique Tractor tent. She had prices of \$ 137 for an 18'x30' replacement canopy and 100 bungee cords for \$37. A board member mentioned checking on a price from TAG in Seymour so Kelly will do this. Dan Megel made a motion to go ahead and purchase the canopy and bungee cords at the best rate at or under the above mentioned prices. **Update as of 4-24-13** Kelly located the company that the original tent was purchased from and found a replacement for \$90 and 50 8" bungees for \$15 with shipping cost of \$15 for a total of \$120. This has been purchased and should arrive within a few days.
